CANCELLATION POLICIES - PLEASE READ THOROUGHLY

*During LOW DEMAND TIMES - Reservations must be cancelled TWENTY-FOUR (24) HOURS prior to arrival date to avoid a flat-rate cancellation fee of \$20.00.

*LOW DEMAND TIMES are when we DO NOT have teacher trainings, workshops, multiple functions or other events occurring on the same dates.

*During HIGH DEMAND TIMES - Reservations must be cancelled SEVEN (7) DAYS prior to arrival date. If your reservation is not cancelled SEVEN (7) DAYS prior to your arrival date, the full room rate for your entire scheduled stay will be considered non-refundable as another guest was turned away for this time.

*HIGH DEMAND TIMES are when we DO have teacher trainings, workshops, special events, multiple functions or other events occurring on the same dates. Examples of this include the weekend of White Tantric Yoga, Fall Festival, the week of Shabd Guru course with Snam, or any trainings. NO refunds will be issued after the date of your stay (e.g. Two nights were booked but only one used).

Note During High Demand Times a minimum stay of the dates of that event are assumed, for example, for a week long event or training a single night may not be booked.

Guru Ram Das Ashram Guest Agreement & Waiver

Guests are welcome and encouraged to visit, study, meditate and stay at the ashram as a licensee (i.e., a non-tenant). It is hoped that every guest will be inspired to participate fully in the life of the community during their stay. Guests of the ashram respect the mission, values, and practices of Guru Ram Das Ashram. Additionally, all ashram guests agree to abide by the Ashram Code of Conduct and to respectfully observe the rules established for the use of all ashram facilities. Ashram guests who are yoga students are expected to abide by all the guidelines of their course programs.

ASHRAM CODE OF CONDUCT - Guru Ram Das Ashram maintains a safe,healthful, and wholesome environment for spiritual practice. We do not allow meat, illicit drugs, alcohol, cigarettes or smoking of any kind, sex outside of marriage, violence, or threats of violence. Permission must be sought before bringing pets or animals onto the property. All Guests are expected to pay all Ashram fees and charges on time and in full and make reservations with the ashram prior to their visit. We reserve the right to require anyone who disregards our policies to leave the ashram and to refuse their entry at any time.

RELEASE AND WAIVER OF LIABILITY AGREEMENT (continued on reverse side)

The participant's electronic signature, provided via CloudBeds as a checkbox, confirms that they read this agreement, understood it, and agree it:

I, as a person staying in Guest Space at Guru Ram Das Ashram, Millis, MA, hereafter called "Guest", assumes sole responsibility for any risks, injuries or damages, known or unknown, which I might incur as a result of participating as a Guest. In further consideration of being permitted to participate as a Guest, I knowingly, voluntarily, and expressly waive any "Claim" (as defined below) I may have against Yoga at the Ashram a/k/a the Baba Siri Chand Yoga Center, Guru Ram Das Ashram, an affiliate of Sikh Dharma of Massachusetts, Sikh Dharma International, and their owners, managers, teachers, instructors, workshop presenters, employees, independent contractors, Board Members and staff (each hereafter known as a "Released Party") from any liability.

As a Guest I assume sole responsibility for securing any and all valuables and/or personal property while staying in Guest Space, and further releases each Released Party from any liability due to theft or damage of valuables and/or personal property. I understand that during my stay I may choose to participate in physical activities outdoors, and I may have certain exposure to poison ivy or wildlife, including ticks which may be associated with tick borne illnesses. I understand that wearing long sleeved clothing and pants and using insect repellent may reduce my exposure to ticks. In further consideration of being permitted to participate as a Guest, I knowingly, voluntarily, and expressly waive any "Claim" (as defined below) I may have against the Released Parties that I may sustain as a result of participating in the Guest Stay even if the claim arises from the negligence of any Released Party or anyone else. I agree to indemnify and hold harmless each Released Party from any loss, cost, or liability incurred in defending any Claim made by me or anyone making a Claim on my behalf, even if the Claim is alleged to or did result from the negligence of any Released Party or anyone else. "Claim" includes but is not limited to any and all liabilities, claims, demands, expenses, fees, legal actions, rights of actions for damages, personal injury, mental suffering and distress, or death that I may suffer, my spouse, children or unborn child may suffer (including any legal fees or expenses) in connection with participation in any Activity. I, my heirs, or legal representatives forever release, waive, discharge and covenant not to sue any Released Party for any Claim caused by any negligence or other acts of a Released Party. This agreement shall be construed in accordance with, and governed by, the laws of the Commonwealth of Massachusetts and that all actions, suits, claims and proceedings relating to this agreement shall be brought in a court of competent jurisdiction located in the Commonwealth of Massachusetts. In case any provision of this agreement shall be held invalid, illegal or unenforceable, it shall not affect any other provision of this agreement and this agreement shall be construed as if such provision had never been contained herein. I acknowledge that I have carefully read this agreement and fully understand its contents. I voluntarily and knowingly agree to the terms and conditions stated herein. I am aware that by signing this agreement, I am giving up substantial rights, including my right to sue and certain legal rights my heirs, next of kin, executors, administrators and assigns may have against any Released Party.
